
















GAIN BANDWIDTH PRODUCT vs. EMITTER CURRENT




INPUT AND OUTPUT CAPACITANCE vs. REVERSE VOLTAGE




SWITCHING TIME VS. COLLECTOR CURRENT



SWITCHING TIME TEST CIRCUIT





